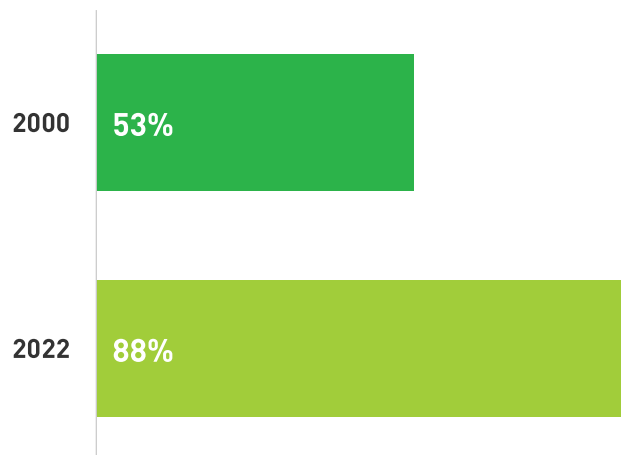

Maternal mortality per 100,000 births, 2019-2023....	18.5
Infant mortality per 1,000 live births, 2023.....	4.6
Preterm birth rate, 2023.....	9%

## BREASTFEEDING IN WIC

Oregon WIC breastfeeding initiation rates increased by **67 percent** between 2000 and 2022.



Among WIC infants who initiated breastfeeding in Oregon in 2022, **34 percent** continued breastfeeding at 6 months.
